



## **GCAHA Weanling ATH Buy-In Futurity**

1. The Futurity will be held at the Tulsa State Fair Arabian Show. Notification will be made if there is a change in show venue. Currently it is held at the Tulsa State Fair with the Tulsa State Fair matching funds at 50%. There is no guarantee Tulsa State Fair will match funds.
2. Foals must be registered with the Arabian Horse Association at time of show and show in corresponding regular halter class at show. Entry fee is \$100. *Weanlings must be registered as an Arabian or Half-Arabian prior to showing and must send registration papers.*
3. Foals must be nominated by March 1. Nominations must be postmarked or email time stamped by March 1. Nomination fee must be sent at the time of nomination unless nomination was sent via email. If email was used to nominate, payment is due within 7 business days. All other nominations will not be accepted unless nomination fee is sent with nomination form. Nomination fee is \$50 and non-refundable and non-transferable. Remainder of payment, \$50 must be paid by due date of entries to sponsored event. All fees are non-refundable and non-transferable.
4. Entries postmarked or email time stamped after March 1 will be considered a post entry and will be charged post entry fee.
5. Post entries may be made for a double fee of \$200, due on the date of entries to sponsored event.

6. Payback is 100%, minus expenses. Money paid to 6<sup>th</sup> place. Original and post entry nomination fees will go into the jackpot of the classes the nominee will show in. Nomination fees that were collected with no entry received will be split evenly between the colt and filly class.

a. Ex: \$100 unallocated Arabian nomination fee. \$50 will go into the Arabian colt class and \$50 will go into the Arabian filly class.

Tulsa State Fair will mail prize money to owners within 30 days of class.

7. Written notification of a transfer of an eligible foal must be provided to the futurity chairperson within thirty (30) days of the transaction. Include a copy of foal Registration papers or Transfer of Ownership. This shall be the responsibility of the new owner. An email between parties constitutes written notification.

8. In the event of any problem or misunderstanding, the decision of the GCAHA futurity committee will be final.

9. Anything not covered in the rules will be discussed and decided by the futurity committee.
